



CoSHH Assessment Workshop



Every year thousands of workers are made ill by hazardous substances, contracting lung diseases such as asthma and cancer or skin disease such as dermatitis. The Control of Substances Hazardous to Health Regulations (CoSHH) require that an employer shall not carry out work liable to expose workers to hazardous substances unless a suitable and sufficient assessment has been made of the risk.

This course explores the CoSHH regulations, explaining terminology and providing good practical tips on carrying out and improving CoSHH assessments.
