Introduction

The NEBOSH National Diploma for Health and Safety Management Professionals is the qualification for aspiring health and safety professionals, building upon the foundation knowledge provided by the NEBOSH National General Certificate. It is a prestigious and demanding course that is internationally recognised as a leading qualification for health and safety.

The diploma itself allows you to have the letters DipNEBOSH allowing for application to GradIOSH and further progression to chartered status.

Entry to the NEBOSH National Diploma assumes a level of knowledge equivalent to NEBOSH National General Certificate and builds from this point. Therefore it is highly recommended that applicants possess a NEBOSH certificate or equivalent level.

All applicants will be evaluated individually considering the knowledge and experience necessary for success on the NEBOSH National Diploma.

Note

Delegates must be proficient in the use of written English as assessments are currently offered, and must be answered, in English only. They must be able to both understand and articulate the concepts contained in the syllabus.
